2. Motion to approve the August 2012 Agenda and May 2012 Minutes by Russell/Pepper; motion carried unanimously.

**Old Business:**

3. The meeting began with a summary of the US 18/151 interchange study Public Information Meeting for preferred alternatives held at the Dodgeville Middle School. The PIM meeting was the last phase of public involvement required for the study portion of the improvements. Representatives from the Wisconsin Department of Transportation presented the preferred alternatives with regards to road improvements and bridge crossings proposed for the USH 18/151 corridor from Dodgeville to the Beltline in Madison. The next opportunity for public involvement will be during the various plan development phases of the interchanges. The westerly interchange to Ridgeway at CTH BB and HHH is anticipated to be the first constructed most likely during 2017. No action taken.
4. Bicycle/Special Events Ordinance discussion. Discussion of complaints received with regards to the summer events held to date. Complaints were received with regards to a recent event "Dairyland Dare" with regards to volunteers flagging bicyclists through an intersection, when the riders should be stopping and the sequence of signage installation and takedown. Jon pepper stated he would have an officer follow-up on the complaints.
