Minutes

Roll Call: All members were present, with Greg Parman excused. Also present were Curt Kephart and Ron Benish.

Reading of Certification: Anderson certified the meeting was posted.

Approve the March 1, 2011 Agenda: Mrozinski made motion to accept. Seconded by Bauer. Carried.

Approve the February 9, 2011 meeting Minutes: Bunker made motion to accept. Seconded by Weaver. Zinck abstained. Carried.

5. Vision Air Software Addendum. Thomas made motion to approve the original proposal from Vision Air not to exceed an average of \$146,412.26 per year, and proceed with the purchase of Mobile AVL, North Pointe Inmate Classification, and Vision CAD paging modules, with resources identified within the current 2011 budget. Zinck made an "amended motion" to Thomas's motion to include that Amy Kaup, IT Director work with Vision Air to secure the current pricing for the Field Based Reporting and Evidence Bar Coding modules so that these two additional modules can be further discussed at a later date. Seconded by Bauer. Weaver, Thomas and Hiltbrand voted no. Carried. The main motion was voted on and it carried, with Weaver, Thomas and Hiltbrand voting no.
