

**Resolution No. 20-1109**

**RESOLUTION SETTING SERVICE PROCESS FEES, JAIL FEES AND ADMINISTRATIVE FEES FOR THE IOWA COUNTY SHERIFF'S DEPARTMENT**

**WHEREAS**, the Iowa County Board sets the Civil Process Fees for the Iowa County Sheriff's Department;

**WHEREAS**, this resolution is effective Nov. 10, 2009 and will replace all prior Civil Process fees;

**WHEREAS**, the following agencies will not be charged for any Civil Process Fees;

- a. Iowa County District Attorney's Office
- b. Iowa County Clerk of Court's Office

**WHEREAS**, a \$45.00 deposit will be required of all non-governmental agencies prior to service.

Now, therefore, the Civil Process Fees will be as follows:

- a. Service Fee -- \$45.00 + mileage
- b. \$20.00 per each additional attempt of service.

Now, therefore, Jail Fees will be as follows:

- a. \$25.00 – Booking Fee
- b. \$20.00 – Warrant Fee
- c. \$20.00 – Fingerprint Fee
- d. \$10.00 – Nurse Visit
- e. \$50.00 – Dr. Visit
- f. \$23.00 – Huber Transfer Fee per day
- g. \$20.00 – Huber Board per day
- h. \$50.00 – Electronic Monitor Hook-up Fee
- i. \$18.99 – Electronic Monitor Fee per day
- j. \$ 5.00 – Alcohol Sensor Fee per day
- k. Fees plus mileage for warrant pick-up: See attachment.

Now, therefore, Administrative Fees will be as follows:

- a. \$ 4.00 – Accident Report
- b. \$ .25 – Photocopies per page
- c. \$10.00 – Copy of Tapes, each
- d. \$ 5.00 – Incident Reports up to five (5) pages.  
.25 – per each additional page

- e. \$ 5.00 -- Temporary Plate Counter Fee
- f. \$ 2.00 -- Duplicate Photographs, per photo
- g. \$25.00 -- CD of Photos and DVD's

Fees are to be collected on a trip that involves picking up a subject on Execution Warrants ONLY.

Fees are calculated by using the shortest calculated route from 1205 N. Bequette St. Dodgeville, WI to the address of the above listed county jails. The route is calculated from [www.mapquest.com](http://www.mapquest.com) and the round trip mileage is multiplied by \$.55/mile. The actual trip mileage may be more, or less than the calculated mileage and the trip may not follow the same suggested route as the calculation was derived from, but this will be the billing standard.. Fees are to be added at the jail at time of booking.
