

ORDINANCE TO AMEND PENALTY SECTION OF  
IOWA COUNTY ORDINANCE PROHIBITING  
CONDUCT RELATIVE TO DISORDERLY CONDUCT

WHEREAS, the Iowa County Board has enacted an ordinance to preserve the public peace and good order within the County prohibiting conduct that is the same as or similar to conduct that is prohibited by Section 947.01 of the Wisconsin Statutes; and

WHEREAS, Section 973.055 of the Wisconsin Statutes provides authority for the imposition of a Domestic Abuse Assessment of Fifty Dollars (\$50.00) for each offense if the court convicts a person for violation of a municipal ordinance conforming to Section 947.01 of the Wisconsin Statutes; and


WHEREAS, the Committee on Courts, Justice & Law Enforcement desires to amend said ordinance to include imposition of a Domestic Abuse Assessment for violation of said ordinance; and


WHEREAS, the Committee on Courts, Justice & Law Enforcement also desires to increase the maximum forfeiture for violation of said ordinance to Five Hundred Dollars (\$500.00) for each offense.

NOW, THEREFORE, BE IT RESOLVED by the Iowa County Board of Supervisors that the Iowa County ordinance prohibiting conduct relative to disorderly conduct be amended to include imposition of a Fifty Dollar (\$50.00) Domestic Abuse Assessment and an increased maximum forfeiture of Five Hundred Dollars (\$500.00) for each offense.


BE IT FURTHER RESOLVED, that this amendment take effect upon adoption and posting, pursuant to Section 59.14 of the Wisconsin Statutes.



Ordinance (No. 8) relative to disorderly conduct charges and the penalty for violation of proposed ordinance was read.

**RESOLVED:** That Iowa County hereby adopts as a County ordinance, Section 947.01 of the Wisconsin Statutes which reads as follows:

Whoever does any of the following, in a public or private place, engages in violent, abusive, indecent, profane, boisterous, unreasonably loud, or otherwise disorderly conduct under circumstances in which such conduct tends to cause or provoke a disturbance.

That the penalty for a violation of this ordinance will be a forfeiture of up to \$200.00.

District Attorney Wayne Rusch addressed the Board regarding the need for such an ordinance and the benefit to the county.

Sup. Cretney moved adoption of the ordinance.

Sup. Laufenberg seconded the motion.

Carried unanimously.
