

RESOLUTION NO. 10-1299

TO THE HONORABLE IOWA COUNTY BOARD OF SUPERVISORS:

WHEREAS, the Committee on Salary and Personnel has evaluated the compensation paid to Iowa County employees who are not represented by collective bargaining units:

WHEREAS, the Committee has considered the need for Iowa County to provide fair compensation to its employees taking into consideration the cost of living;

WHEREAS, the Committee believes that the County's non-bargaining compensation schedule and system should be re-evaluated to assure that the salaries of non-bargaining employees are consistent with applicable requirements of federal and state law:

NOW THEREFORE, BE IT RESOLVED, by the Iowa County Board of Supervisors, that the following schedule of salaries and compensation be paid to non-bargaining employees during 2000:
