**RESOLUTION AUTHORIZING THE EMPLOYMENT OF TWO (2)
ON-CALL IOWA COUNTY SHERIFF'S DEPARTMENT
DISPATCHERS/JAILERS**

WHEREAS, the Iowa County Sheriff's Department at times has need of on-call Dispatchers/Jailers to accommodate the full-time Dispatchers/Jailers who wish to exercise the use of their sick leave, personal holiday and vacation;

WHEREAS, the Committee on Courts, Justice and Law Enforcement with the concurrence of the Committee on Salary & Personnel recommends the employment of two (2) On-Call Iowa County Sheriff's Department Dispatchers/Jailers to accommodate said Department's needs when regular full-time Dispatchers/Jailer staff are at times unavailable;

WHEREAS, the significant training period and personnel expense necessary to train qualified On-Call Dispatcher/Jailers necessitates provision for a training wage and provision for County benefits in order to attract suitable candidates;


NOW, THEREFORE, BE IT RESOLVED BY THE IOWA COUNTY BOARD OF SUPERVISORS that:

1. The Committee on Courts, Justice & Law Enforcement shall have authority to recruit and employ subject to the County Personnel Policies two (2) On-Call Iowa County Sheriff's Department Dispatcher/Jailers;
2. The training wage for said positions shall be at the rate of Eight Dollars (\$8.00) per hour;
3. After successful completion of all training requirements and after attainment of prerequisite qualifications customarily necessary to perform the duties of a Dispatcher/Jailer said wage shall increase to Ten Dollars and Four Cents (\$10.04) per hour;
4. In addition to the wage referred to above said On-Call Dispatcher/Jailers shall be entitled, if eligible, to:
 - (a) Basic Group Life Insurance under the provisions of Chapter 5 of the Department of Employee Trust Funds Group Life Insurance Administration Manual;
 - (b) Group Health Insurance under the provisions of Chapter 3 of the Department of Employee Trust Funds Local Health Insurance Administration Manual; and


- (c) Wisconsin Retirement System participation under the provisions of Chapter 3 of the Department of Employee Trust Funds Wisconsin Retirement System Administration Manual.
