**RESOLUTION SETTING SERVICE PROCESS FEES, COPYING FEES AND
BOOKING FEES
FOR THE IOWA COUNTY SHERIFF'S DEPARTMENT**

WHEREAS, the Iowa County Board sets the Civil Process Fees for the Iowa County Sheriff's Department;

WHEREAS, this Resolution is effective August 21, 2007 and will replace all prior Civil Process fees;

WHEREAS, the following agencies will not be charged for any Civil Process fees;

- a. Iowa County District Attorney's Office
- b. Iowa County Clerk of Court's Office

WHEREAS, a \$45.00 deposit will be required of all non-governmental agencies prior to service.

Now, therefore, the Civil Process Fees will be as follows:

- a. \$45.00 Service Fee
- b. \$20.00 Each Additional Attempt of Service
- c. \$3.00 surcharge to current flat fees for mileage

Now, therefore, copying fees will be as follows:

- a. Fees for photocopies shall be four dollars for up to five (5) pages and twenty-five cents (\$.25) for each additional page.
- b. Fees for tape copies shall be ten dollars (\$10) for each tape.
- c. Fees for CD copies shall be \$20.00 for each CD.

Now, therefore, jail booking fees will be as follows:

- a. \$25.00 fee for booking services
