

**Resolution Number: 4-0407**

**Whereas**, the Iowa County Board of Supervisors did adopt the Iowa County Non-Metallic Mining Reclamation Ordinance as required by Section 295.1391), Wisconsin Statutes and Section NR 135.32, Wisconsin Administrative Code;

**Whereas**, the administration and enforcement of said ordinance comes at a cost;

**Whereas**, this cost should be borne primarily by those in need of the service versus the general tax payer;

**Whereas**, it has been determined, based upon the relative expense to the administrative authority, that a permit fees should offset most of the costs;

**Now Therefore Be It Resolved** that the Iowa County Board of Supervisors does hereby adopt this resolution setting permit fees as follows associated with the administration and enforcement of the Iowa County Non-Metallic Mining Reclamation Ordinance:
