Amendatory Ordinance No. 3-1015 for a land use change to zone 22.326 acres from A-1 Agricultural and AR-1 Agricultural Residential to all AR-1 Agricultural Residential in the Town of Ridgeway was presented and adopted.

Amendatory Ordinance No. 4-1015 for a land use change to zone 3.18 acres from A-1 Agricultural to AR-1 Agricultural Residential and 36.82 acres having the AC-1 Agricultural Conservation overlay in the Town of Waldwick was presented and adopted.

Amendatory Ordinance No. 5-1015 for a land use change to zone 16 acres from A-1 Agricultural to RR-1 Recreational Business and 35.6 acres from A-1 Agricultural to AR-1 Agricultural Residential in the Town of Waldwick was presented and adopted.

Sup. Bunker moved to amend the resolution by adding that supervisors get paid mileage for attending committee meetings they are not a member of. Sup. Meek seconded the motion. Amendment carried.

Sup. Griffiths moved to amend the preliminary budget by taking \$32,184 from the 2016 Contingency Fund and use it to restore the OWI funding. Sup. Benish seconded the motion.

Sup. Benish moved to amend the amendment by taking the \$32,184 from the 2015 Contingency Fund. Sup. DeLain seconded the motion. Motion failed.
