

A Resolution Approving The Sale Of Alcoholic Beverages At The Tri-County Regional Airport.

WHEREAS, long ago the County Board of Supervisors of Iowa, Richland and Sauk Counties, which are the three counties which own the Tri-County airport in Lone Rock, approved a form of lease whereby the Tri-County Airport Commission could lease the restaurant at the airport to a private operator and the approved lease form prohibited the sale of alcoholic beverages in the restaurant; and

WHEREAS, the Commission has entered into a lease of the restaurant with Marjorie A. Windrem and her husband, former Richland County District Attorney Edward E. Lindweber and Cynthia D. and John M. Jenkins who operate a restaurant known as the Wild River Cafe at the Airport, and these persons now desire to sell alcoholic beverages at the Wild River Cafe and they have obtained a Class B Fermented Malt Beverage license and a Class C Wine license for the Cafe from the Town Board of Spring Green; and

WHEREAS, the Tri-County Airport Commission believes that it would be in the best interest of the successful operation of the restaurant at the Airport and in turn in the best interest of the the Airport itself and the economic vitality of the surrounding community, if the County Board of Supervisors of Iowa, Richland and Sauk Counties would authorize the amendment of the restaurant lease form so as to permit the sale of alcoholic beverages at the Airport's restaurant; and


NOW, THEREFORE BE IT RESOLVED, by the Iowa County Board of Supervisors that the form of lease for the restaurant that the Tri-County Airport Commission is authorized to utilize when leasing the restaurant at the Airport is hereby amended to expressly permit the sale of alcoholic beverages in the Airport's restaurant by the tenant-operator of that restaurant as long as such sales are in compliance with alcoholic beverage licenses granted by the Town of Spring Green, and


THEREFORE IT BE FURTHER RESOLVED, that permission is also granted to amend the existing lease between the Commission and Marjorie A. Windrem, Edward E. Lindweber, Cynthia D. and John M. Jenkins, doing business as the Wild River Cafe, so that alcoholic beverages can be sold at the Wild River Cafe in accordance with Class B Fermented Malt Beverage license and Class C Wine Alcohol license granted to the Wild River Cafe by the Town Board of Spring Green, and


THEREFORE BE IT FURTHER RESOLVED that this Resolution shall be effective upon the adoption of a like resolution by the County Board of Supervisors of Richland and Sauk Counties.


