## RESOLUTION NO. 9-795

RESOLUTION AUTHORIZING THE DESIGNATION OF AN ATTORNEY TO ACT AS IOWA COUNTY CORPORATION COUNSEL FOR THE LIMITED PURPOSE OF RENDERING LEGAL OPINIONS AND/OR ADVICE CONCERNING SPECIFIC DISCIPLINARY MATTERS

- WHEREAS, the Department of Social Services Board of the Iowa County Board of Supervisors is in need of a legal opinion and/or advice regarding disciplinary matters which involve an employee and/or employees of the Iowa County Department of Social Services;
- WHEREAS, the Department of Social Services Board believes that the Iowa County Corporation Counsel cannot render a legal opinion regarding said disciplinary matters due to what may appear to be a conflict of interest;
- WHEREAS, the Office of the Dane County Corporation Counsel has indicated its willingness to assign an Assistant Corporation Counsel to provide a legal opinion and/or advice concerning said disciplinary matters;
- WHEREAS, Section 59.457 of the Wisconsin Statutes provides authority for the Iowa County Board of Supervisors to designate an attorney to perform the duties of a corporation counsel when the need to do so arises.
- WHEREAS, the Department of Social Services Board recommends that the Iowa County Board of Supervisors designate the assigned Assistant Dane County Corporation Counsel to act as Iowa County Corporation Counsel for the limited purpose of rendering a legal opinion and/or advice concerning disciplinary matters which involve an employee and/or employees of the Iowa County Department of Social Services.
- NOW, THEREFORE, BE IT RESOLVED by the Iowa County Board of Supervisors that:

Pursuant to Section 59.457 of the Wisconsin Statutes, it authorizes the designation of an Assistant Dane County Corporation Counsel to act as Iowa County Corporation Counsel for purposes of rendering a legal opinion and/or advice concerning disciplinary matters which involve an employee and/or employees of the Iowa County Department of Social Services.

IT IS FURTHER RESOLVED by the Iowa County Board of Supervisors that it will reimburse Dane County for expenses incurred as a result of the above said designation.
