RESOLUTION No. 3-796

To: Honorable Members of the Iowa County Board of Supervisors

RE: Agricultural and Household Hazardous Waste Collection (Clean Sweep)
Program

A RESOLUTION authorizing the submittal of state grant applications and subsequent appropriation of county funds for a combined agricultural and household hazardous waste collection program for Iowa County.

WHEREAS, Iowa County recognizes the benefits of a program to control the disposal and storage of potentially hazardous agricultural and household waste and will carry out all activities described in the state grant applications to the Dept of Agriculture and the Dept of Natural Resources; and,

WHEREAS, the County's Clean Sweep programs are intended to offer education and assistance to citizens in the identification, proper handling and disposal of agricultural and household hazardous waste through distribution of public information materials, presentations to citizen groups and a designated day for the collection and disposal of agricultural and household hazardous waste; and,

WHEREAS, Iowa County successfully organized and conducted an agricultural Clean Sweep Day in June 1993 and the County Board is considering a collection in June 1997; and

WHEREAS, in this and previous action the County Board has declared its commitment to continued information and education programs as well as Clean Sweep Programs subject to public response and the appropriation of funding; and,

WHEREAS, Iowa County will allow employees from the Dept of Agriculture and Dept of Natural Resources access to inspect the Clean Sweep Program site; and,

WHEREAS, Iowa County will maintain records documenting all expenditures made during the Clean Sweep program; and,

WHEREAS, the estimated cost of the Agricultural Clean Sweep is \$25,000 with \$20,000 available from the Dept of Agriculture and an additional \$5,000 requested from Iowa County; and,

WHEREAS, the estimated cost of the Household Clean Sweep is \$25,000 with \$15,000 available from the Dept of Natural Resources and an additional \$10,000 requested from Iowa County; and,

WHEREAS, Iowa County will submit a final report to the Dept describing all Clean Sweep Program activities, achievements and problems, comparing the actual program with the activities and objectives proposed in our application, including samples of our information-education brochures, data on participation rates, waste quantities collected, documentation of the project costs, and a section on recommendations.

THEREFORE, BE IT RESOLVED, that the Iowa County Board of Supervisors authorizes the UW-Extension Iowa County Office to submit state grant applications for the Agricultural and Household Hazardous Waste Grant Programs with the intent of administering a Clean Sweep Program in Iowa County in 1997.
