6. **Open Session – Comments from Audience/Committee Members:** Sup. Jeremy Meek addressed the topic of the office layout in the new Health & Human Services building. Sup. Meek explained his rationale for placing the matter on the agenda for last month in that having a person direct people upon entering the new building would enhance customer service. Committee reiterated last month's discussion and the position that the matter would be better served by the building committee.

Unified Community Services

Unified Community Services Director Neal Blackburn gave an update on the current status of the Family Care CMU's. He reports that the decision by the Southwest Family Care Alliance to discontinue county involvement in the care management portion of family care will likely reduce his staff by 11-12 positions. Employees housed in the Dodgeville office would be reduced by approximately ½ of the current staffing level. Staff that are being hired into the newly created positions within SFCA will be notified by September 10, 2010.

Bloomfield Health Care & Rehabilitation

Sup. Ron Benish reported on the proposed changes to the current fee structure at Bloomfield Health Care & Rehabilitation. This is done on an annual basis and the numbers and methodology utilized were gone over by Sup Benish. Motion by Sup Mrozinski, seconded by Sup. Grover to accept and approve modifications to fee structure. Motion carried.

Social Services Department

Social Services Director Darin Smith presented 2009 annual report. Motion by Sup. Nankee, second by Sup. Parman to forward report to full county board at next scheduled county board meeting.

Other

Committee went over request from Long Range Planning Committee to have each standing committee present 3 items at the LRP September meeting to utilize in a county wide long range planning process. Iowa County Health, Bloomfield and Social Services presented prioritized lists of possible alternatives specific to each of those departments. Discussion surrounding process to choose 3 items from the 30+ presented and possible ideas that were of a broader nature and could encompass multiple departments and/or all county agencies. Item will be present on the September agenda to solidify the three needs the Health & Human Services will be presenting.
