Unified Community Services Director Neal Blackburn gave an update on the purchase of a crisis diversion bed from Cornerstone Foundation for situations where an emergency detention is not necessary. The rental cost for the bed is approximately \$22,000 annually. Director Blackburn also reported that the family care transition of employees will be occurring on Dec 13, 2010. Iowa County

will be losing 5 staff while Grant County will be losing 6 staff. Southwest Family Care Alliance has offered positions to all Unified staff that applied with their agency. Director Blackburn gave an update regarding the possibility of Grant County exploring a move to transition to a human services agency. There is a meeting scheduled for Nov. 8, 2010 with the city administrator for Lancaster as well as the Mayor of Lancaster. They plan to discuss impacts of moving offices into the city including parking issues prior to deciding if a feasibility study should be done.

Bloomfield Health Care & Rehabilitation

Sup. Ron Benish presented a resolution in regards to the State Biennial Budget and how funds are allocated to the county nursing homes. The resolution is requesting that Governor and State Legislature support a change in statute which modifies the way funding is disseminated specifically in regards to monies related to nursing home bed assessment funds and the matching federal funds. Motion by Sup. Pilling, second by Sup. Parman to approve the resolution. Motion Carried.
