1	Meeting was called to order by Chairman Mrozinski.
2	Member present: Supervisors Bomkamp, Bunker, DeLain, Mrozinski, Palzkill, and Nankee. Absent: Sup. Clerkin. Others present: Admin. Kephart, Corp. Counsel Allen, Sheriff Michek, Chief Dep. Bennett, Jail Admin. Pam Steffes and Emerg. Mgmt Hurlbert.
3	Sup. Bomkamp moved to approve the agenda for this March 3, 2015 meeting. Sup. Palzkill seconded the motion. Carried.
4	Sup. DeLain moved to approve the minutes of the October 28, 2014 meeting. Sup. Bunker seconded the motion. Carried.
5	Comments or reports from the audience or committee members. Introductions: Jail Administrator, Pam Steffes and Chief Deputy, Steve Bennett. Discussion on the Humane Society officer position with a reduced budget of \$20,000.
6	Revenue & Expenditure Reports: Discussion on the Restorative Justice – TAD Grant Expenditures and 2015 Revenue for Emergency Management and OWI-ISP Offices.
7	Update from committee departments: Written reports were received from Dist. Atty Larry Nelson advising the Justice Committee of the office workload and Child Support Director, Deb Rosenthal cases and revenue obligations.
8	Review Revised Highway Access for Special Events Ordinance as presented by the Transportation Committee. Discussion on the Special Events Ordinance (not bike ordinance). Motion by Sup. DeLain to strike entire 2.1J (Road Marshalls & Flagging Personnel) and make corrections and send the Ordinance to the entire board for approval, seconded by Sup. Bomkamp. Carried
9	Corporation Counsel Allen updated the committee on Drug Treatment status and Attic Correctional Services. Report given on the ATV routes and DNR updating; airport and Bloomfield issues.
10	Emergency Management report given by Keith Hurlbert on Ebola planning and organizing in Iowa County. Nixle use has increased since the 2014 tornado disaster. Presentations and planning are being organized on Disaster Recovery and partnering with non-governmental organizations.
11	Sheriff's Department Report. Discussion on Airport/aviation training for deputies. Sheriff Michek gave an employment report. Jail Administration commented on inmate and mental health challenges. Discussion partnering with public schools.
12	Next meeting will be 31 March or 7 April if needed.
13	Sup. Bunker moved to adjourn at 7:19 p.m., seconded by Sup. Bomkamp. Carried.
