| #3 | Mr. Casper requested the committee consider allowing comments from the public during discussion of agenda items. No other comments from the public. Commissioner Hardy stated other counties were in different phases of implementation of policies due to differing dates of expiring Bargain Agreements. And, the policies being set forth were specific to each county's decisions. A matrix outlining where other counties were at in the process of creating policies and a summary of some of the other county policies was reviewed and discussed. Motion by DeLain, second by Benish to adopt a basis of overtime similar to Columbia County's (pay overtime rates for over 40hrs worked/week, weekends and holidays = time and a half) as an addendum to the on-call policy for the highway department. Motion failed on a 4-4 tie with Benish, Bunker, Demby and Parman for and DeLain, Meyers, Peterson and Walmer against. Vote was then taken on the original motion.
